## Introduction to European Union Transnational Law

The aim of this course is to provide students with a basic understanding of how the European Union uses the law as a means to achieve market objectives through national and international business transactions. To this end the class will examine the basic components lawyers need to know when preparing to draft contracts involving EU member states. These include:

- the emergence of the European Economic Community
- how the European Union is administered/governed by the four main institutions
- the sources and general principles of the European Community law
- how European Community law is integrated at a national level
- the contributions of the Court of Justice to this process
- how European community law is enforced at both a national and European level
